

INSTRUCTIONS

1. A REBATE CLAIM SHOULD NORMALLY COVER THE PERIOD OF AT LEAST 3 MONTHS AND BE GREATER THAN **\$100.00**.
2. THE FOLLOWING DOCUMENTATION IS REQUIRED:
 - (a) A PROPERLY COMPLETED AND REGISTRATION INFORMATION FORM THAT HAS BEEN SIGNED BY THE APPLICANT.
 - (b) A PROPERLY COMPLETED REBATE APPLICATION FORM WHICH HAS BEEN SIGNED BY THE APPLICANT.
 - (c) A REBATE SUMMARY SHEET MUST BE PROPERLY COMPLETED AND ATTACHED TO THIS REBATE CLAIM.
 - (d) ORIGINAL INVOICES MUST BE ATTACHED TO THE APPLICATION. THESE WILL BE RETURNED AFTER THE REBATE HAS BEEN PROCESSED.
3. ALL INVOICES MUST MEET THE FOLLOWING CRITERIA:
 - (a) THE INVOICE MUST BE AN ORIGINAL.
 - (b) THE INVOICE MUST CLEARLY SHOW THE SELLERS NAME.
 - (c) THE INVOICE MUST CLEARLY SHOW THE PURCHASERS NAME.
 - (d) THE INVOICE MUST CLEARLY SHOW THE QUANTITY AND TYPE OF FUEL PURCHASED AND TOTAL PRICE CHARGED.
 - (e) THE DATE OF THE PURCHASES IS WITHIN THE CLAIM PERIOD OF THIS CLAIM
 - (f) THE DATE OF THE PURCHASE COINCIDES WITH THE FISHING LICENCE SEASON.
 - (g) A RECEIPT INDICATION PAYMENT OF THE INVOICE.
4. REBATES MUST BE APPLIED FOR WITHIN THREE YEARS OF THE DATE OF PURCHASE.
5. THE TAX RATE IS AS FOLLOWS:

UNLEADED GASOLINE - 16.5 CENTS PER LITRE.
6. CLEAR DIESEL IS NOT ELIGIBLE FOR REBATE. APPLICANTS SHOULD APPLY TO THE DEPARTMENT FOR A PERMIT TO PURCHASE MARKED DIESEL.
7. REBATE CLAIMS USUALLY TAKE ABOUT 8-10WEEKS TO BE APPROVED AND PAYMENT ISSUED. IF AFTER THIS PERIOD, YOU HAVE NOT BEEN CONTACTED CONCERNING YOUR CLAIM, YOUR ENQUIRY MAY BE DIRECTED TO THE TAXATION OFFICE LISTED BELOW.
